+ All irrigation system installations must be installed by a State of Texas licensed irrigation installer.

** All backflow devices must be tested by a State of Texas licensed tester and a passing Backflow Prevention Assembly Test Maintenance Report must be provided to the Inspector. The cost of backflow device testing is not included with the irrigation, pool, or remodel permit and must be paid for separately.*



1. By signing this form, you are acknowledging that you are a licensed plumber and are aware that you are the only person that can call in for the inspections. The District Office issuing the permit will email a copy of the permit to the contracted Inspector, Troy Gray with I.O. Inspections, who will then accept inspection requests by the assigned plumber. **The plumber/plumbing company will be solely responsible for all plumbing inspections.**
2. **Any additional inspections required beyond the original inspections paid for will require additional fees that will be due and paid to the Hurst Creek Municipal Utility District before re-inspections or additional inspections can be requested.**
3. The plumber is responsible for closing the permit by contacting our District Office and will be responsible for all inspections until permit is closed. **Please note that all work and inspections must be complete within one year of the date this Permit is issued, as the Permit is only valid for a term of one year from the date of issuance. If the required passing inspections have not been completed within one year, a new permit must be applied and paid for.**

Prior to the start of any work, a licensed plumber must pull a plumbing permit from Hurst Creek Municipal District at 102 Trophy Drive. The District uses I.O. Inspections as its only commercial and residential inspection company. Plumbing inspections are separate from building inspections, which may be required by The Hills Property Owners Association. Work started without a plumbing permit is subject to stop work orders, disconnection of services and rework. **The licensed and authorized plumber may contact Troy Gray at <https://ioinspections.com/schedule-inspection> to schedule an inspection after a permit is issued.**

All plumbing work performed in the Hurst Creek Municipal Utility District's jurisdiction must comply with the latest adopted Uniform Plumbing Code and all Hurst Creek MUD Regulations.

Applicant agrees to comply with all rules and regulations and pay all established charges and fees of the District now existing and acknowledges responsibility for requesting and verifying all inspections of any plumbing installed.
